## 18th members deploy to support Operation Noble Anvil

Seven members of the 18<sup>th</sup> Air Refueling Squadron are participating in exercises relating to potential NATO operations in Kosovo.

Three 18<sup>th</sup> members augmented a force of approximately 100 members of the 22<sup>nd</sup> Air Refueling Wing, McConnell Air Force Base's active duty refueling wing, in refueling operations as part of the

movement of aircraft to U.S. bases in Europe. The 931<sup>st</sup> also provided one complete, four-person aircrew to assist the mission through a separate requirement.

Lt. Col. Ron Johnston, the 18<sup>th</sup>'s operations officer, said the complete crew was on a two-week rotation that would be replaced by another 931<sup>st</sup> crew after the initial hitch.

## 931st enters drug testing program

Unit previously exempt

The medical office reports that February's random urinalysis testing is a permanent change.

Personnel will be selected at random on a quarterly basis for urinalysis.

Thirty-eight 931st personnel submitted to surprise urinalysis during the February UTA.

Personnel who have been selected and tested once are not precluded from being selected again.

Tech. Sgt. Paul Hudson, an aeromedical technician assigned to the 931st, said it is important for reservists to have complete, updated records on medications they are taking to avoid problems with urinalysis.

The testing is nothing new for the Air Force Reserve, but the 931st had previously been exempt during its initial three-year stand up phase.

# A slight change in vector

The 931<sup>st</sup> has done an outstanding job in its short history since it was reactivated in 1995. We have fought our way through difficult times without being given all the tools we might have hoped for. Our growth continues and we have been looking ahead in hopes of finally getting a wing structure. Well, that wing structure may be delayed.

Last week I was informed by General Whaley that negotiations have been going on to try to place the 513th ACG (the AWACs associate unit that is currently administratively supported by the 507th Air Refueling Wing at Tinker), under the 507<sup>th</sup> as a subordinate group. This would allow the 507<sup>th</sup> Wing Commander position to become a general's billet. Air Combat Command blocked the move and as a result, in order to save the general's billet, the 931<sup>st</sup> has been aligned under the 507<sup>th</sup>.

It is easy to be discouraged by this move, however, there should be very little change to the way we do business. No one's job will be eliminated and we will stay in control of our flying time and budget.

Personnel promotion actions that heretofore went directly to 4th Air Force and pooled together with the Regional Support Group will now be considered with the 507 ARW. Therefore, PEP boards and PRFs will now be considered in a smaller sample size of personnel, which could benefit us. When the 507<sup>th</sup> has a PEP board we will have some of our members on the board, when our records went directly to 4th AF we were lumped together with the RSG and had no representation on the

board. The PRFs will now go to the BG at the 507<sup>th</sup> instead of going to Gen Whaley. Once again we will be in a smaller sample size and therefore instead of meeting the board with a commander's score of 15/30/45 you might be 2/5/8.

Our relationship with the 22 ARW will also remain as it has been. We will continue to be separately tasked but try to help the 22<sup>nd</sup> whenever possible. We will continue to be linked with the 22<sup>nd</sup> as an associate unit and take our evaluations and ORIs with them, not the 507<sup>th</sup>.

The 507<sup>th</sup> change of command will take place on Saturday, 6 March. After the change of command, I will be able to release

the general's name who will be assuming command of the 507 Wing. I can tell you that I know him personally and anticipate a great relationship.

Since the announcement I have talked to many of you and know your concerns. The bottom line is this decision should not be misconstrued as a slap in the face. It was more of being in the wrong place at the right time, or more to the point, in the wrong structure at the right time. As an unattached group we were prime pickings for this kind of alignment. Continue to do the outstanding job you always have and all the other things will work themselves out, including becoming our own wing.



This form also serves as the official document required by law for designating beneficiaries for death gratuity pay and unpaid pay and allowances.



# Access unclassified Intelligence with a click

Have you ever had a question about an international situation or a current event and not known where to look?

Have you ever been off-station, at home, or at your civilian job, and had questions?

Have you ever been working on a degree program, a professional military education course, or has your boss asked you about a current event and needed the

information?

Here's the solution for you! 2<sup>nd</sup> Lt. Jeff Jeskie developed a simple, easy to use, on-line directory of web sites for the 931<sup>st</sup> Intelligence Directorate. These web sites reside on the unit's local area network. This unclassified site provides a wealth of information on virtually every event of interest worldwide!

To access this awesome database, simply turn on your computer, double click on the My Computer icon, then double click on the Public 1 on 'iab03' (M:) (the M drive). This will take you



to the Public folders. Then select the Intelligence folder. Chose between two files: the Intelligence Oversight briefing or Intelligence Web sites. Upon opening individual folders you will find a

word document. Click on the word document and you will see a list of unclassified "Intelligence related" web sites. All sites have hyperlinks to the specific web page.

The rest is up to you: whether you want information on North Korea, Iraq, Kosovo, Russia, Europe, Asia, Terrorism, Information Warfare, or News updates. It's all there in the Unclassified Intelligence file on the M drive.

## New computer system streamlines travel process

WASHINGTON (AFPN) — Does this temporary duty checklist sound familiar? Request orders. Call travel. Make rental car, hotel and airline reservations. Get a cash advance. Pick up tickets. Pack. Go. Come back. Save receipts. File voucher. Check mail for travel pay. There is relief in sight.

The Defense Department's new temporary duty travel system, set to be fielded worldwide by 2001, is "quicker, easier and better" than the current system with all its forms and vouchers, according to Army Col. Albert E. Arnold III.

Arnold, head of the Defense Travel System Project Management Office here, said the new computer-based system streamlines the entire travel process. Everything from getting orders to making hotel and airline reservations to filing reimbursement vouchers is done electronically.

"Everyone will love it," Arnold promised. "Travelers will be able to make reservations right from their desktops. Where today you talk to the travel agent by phone or in person, you'll be able to see all your choices right on your desktop." Travelers with no access to a computer at work will be able to make their travel arrangements and file their travel vouchers at their unit's administrative center.

Getting reimbursed for travel expenses will also be faster and easier, he said. "You'll just file your voucher straight from your desktop without inputting travel data

a second time."

Currently, once the temporary duty is complete, the specific travel details are entered onto a DD Form 1351-2 voucher. With the new system, the information will be entered into a database once. Some information, such as accounting classifications, will be preloaded into the program to be selected from pull-down menus. Returning travelers will have to update only changes to their itinerary, Arnold said.

Once the voucher is complete, the traveler will electronically forward it to his direct supervisor for approval. "The beauty of the system is that it will be a completely paperless process from end to end," he noted.

The new system also eliminates the need for filing receipts for travel expenses. The receipts must be maintained, but they need not be filed with the voucher. Travelers must keep receipts for all lodging costs and for expenses over \$75, Arnold said. "The honor system now covers expenses under \$75."

"Should somebody want to see them in the future — the authorizing official, your boss, a reviewer or auditor — then you'll need to produce them, much as the same as you do for your income tax. If you get audited by the IRS and you can't produce a receipt, you lose. The same thing will be true for the defense travel system."

The new system is based on the premise that both travelers and supervisors are

honest and responsible, Arnold said. In revamping the system, defense officials eliminated layers of approval authorities, giving supervisors authority to approve temporary duty travel and travel vouchers.

Each agency and organization will determine where this authority will be vested, but it should go to the lowest level supervisor that has the responsibility and resources (time, people, and travel budget) to perform the given mission.

"The person who's now going to review your claim for payment is going to be your first line supervisor," Arnold said. "He or she knows how much he or she can trust you. They're going to look at your claim, much the same as the Defense Finance and Accounting Service does today."

Another change to the system eliminates the need to certify official telephone calls, a requirement dating back to 1939. Under the new system, he said, official telephone calls will be listed as a separate reimbursable expense on travel vouchers.

Defense officials are planning an extensive training program to acquaint travelers with the new procedures, Arnold said. "Our office will train trainers in different units around the world who will then train their units. They can then incorporate any local procedures that might be necessary." Online help will also be available, he added.

Office in Washington was one of the pilot test sites. Budget officer Angela M. Talaber there praised the new electronic system, particularly the speed with which people are paid -- in some cases, within a day or two.

"If finance pays the voucher in the afternoon, most times the money goes to the Federal Reserve Bank the next day," Talaber said. "Within two days the money is direct-deposited in the traveler's bank account. I've had folks who filed a voucher at 7 a.m. and it was

processed and paid the same day." The travel system is being lab tested to ensure all the technology works, Arnold said. "We're really kicking the tires to make sure the system works the way we want it to work before we field it to anyone else."

By 2000, defense officials expect to put the system at bases overseas.



# Certificates honor Cold War warriors

WASHINGTON — Between 18 million and 22 million former and current service members are eligible to receive certificates honoring them for their parts in winning the Cold War.

The Army — the executive agent for the program — will start taking applications on April 5. The Army will accept applications for the certificate by Internet (at <http://sdcw.army.mil/coldwar>), e-mail, fax and mail. Shari Lawrence, a U.S. Army Total Army Personnel Command spokesperson, said the addresses will be released around March 15.

"If we put the addresses out now, people will start sending in applications and we're not ready to accept them yet," she said. Applicants must use fax or mail to submit supporting documents. The Army has printed 1 million certificates.

"We just don't know how many people will apply for the

certificates," Lawrence said.

Persons are eligible for the recognition certificate if they have military or civilian service with the War, Navy or Defense departments between Sept. 2, 1945, and Dec. 26, 1991. Applicants with citing military service can present the following records as proof: DD Form 214 (Certificate of Release/Discharge from Active Duty); WD AGO Form 53-55 (War Department Separation Document); or Oath of Office — Military Personnel or Letter of Appointment. - Excessive outside demands to allow continued participation in the Reserve


- Quality of life in the AF Reserve wasn't what I expected
