## Homecoming complete for 931st ARG

The last members deployed in response to the Kosovo conflict returned home to McConnell Air Force Base during the first two weeks of July.

The 13 members, who were deployed to different locations in Europe for over 6 weeks, began returning over a two-week period beginning July 1.

Three members of the 931<sup>st</sup> Intelligence unit were deployed for six weeks assisting the 191<sup>st</sup> Air Refueling Squadron from Salt Lake City, Utah, during the Kosovo conflict.

Major Steve Kett, chief of intelligence directorate; Staff Sgt. William Durand, noncommissioned officer in charge of intelligence operations; and Staff Sgt. Russ Hunt, noncommissioned officer in charge of system intelligence, returned home on July 3 after assisting in Operation Allied Force at Souda bay Naval Support Activity in Crete, Greece.

The trio were responsible for preparing crews about the local threats and special precautions to take while stationed in Greece. "We provided pre-mission briefings, situational analysis, anti-terrorism briefings, force protection and post-mission briefings," said Kett.


The intelligence briefings were extremely critical in Greece because of the increasing terrorist threats during the operation. "The state department was calling it Europe's unsafest place," said

Kett, "We actually had an archive of recent events that went back to March and April." One precautionary measure was to terminate the contract of a local company who was renting vehicles to the deployed members. "We dumped the vehicle contract, because the (license) plates were leaked to the local press that they began with the letters XNE," said Kett, "The local papers were also calling us the bloody Rambo's, because the Marines were storming ashore."

While stationed with the 191<sup>st</sup> the three members developed a lasting rapport. "It was a good experience," said Hunt. "The 191<sup>st</sup> took really good care of us. We had some barbecues, and we flew on several missions," said Kett, "I participated in refueling Tornados and some Mirage aircraft."

Master Sgt. Donna Lorenz, 931<sup>st</sup> ARG noncommissioned officer in charge of logistics, returned home July 1 after serving voluntarily for 60 days at the Headquarters for United States Air Forces in Europe located at Ramstein Air Base, Germany.

Lorenz was responsible for ensuring that everyone and everything got to its proper location. In some cases this included starting with nothing on the ground and finishing with a full operational base, according to Lorenz. "We surveyed 33 locations for possible beddown of forces use," said Lorenz. "My involvement was to coordinate all efforts so each location could be completed," said Lorenz, "One example was the use of a Harvest Falcon. A Harvest Falcon provides the facilities for

the creation of a full operational base in about 30 to 45 days."

A major success for Lorenz was the creation of checklists for use in of future deployments. "We created a functional checklist of lessons learned for future conflicts," said Lorenz. "The checklist was created so they (future deployers) could have a list of questions ready that weren't asked in the past, because if the question isn't there, then the question can't be

asked." Lorenz's hope is that the checklist will help reduce the amount of repeat site visits that occurred during this deployment.



### Where do I go for help?

Have you ever been faced with a problem or needed an answer to a question and did not know where to go for help?

In an ideal world, every problem would be solvable at the lowest level in the chain-of-command. Your immediate supervisor would always have the answer or be able to direct you to the appropriate agency for help. In the real world, however we know that it does not always work that way. In spite of our best intentions, there are times that, for a variety of reasons, we cannot resolve the issue at the individual/supervisor level.

There are other avenues to pursue in such cases, including taking the issue up the chain-of-command or contacting the IG. Whether you are considering filing a formal complaint or just need help resolving an issue, we can be of help.

The first thing we will do is determine whether your issue belongs in the IG system or should be worked through other channels first. AFI 90-301 specifies that before the IG becomes involved in an issue, any other existing avenues of redress or appeal must first be pursued.

If you are not sure where your particular problem rightly belongs, talk to us about it. We will work with you to determine the most appropriate avenue to pursue to get a timely resolution to your issue.

# Study recommends greater use of reserve forces

WASHINGTON - Creating more associate units and evaluating the transfer of more active-duty bombers and fighters are among the suggestions made by the Reserve Component Employment 2005 Study announced July 22.

RCE-05, a one-year, Department of Defense-wide collaborative effort, formulated recommendations to Secretary of Defense William Cohen for new and better ways to employ reserve forces and foster Total Force integration.

"The RCE-05 study is an important step in an ongoing and rigorous process of identifying new and better ways of using the reserve components," said Charles L. Cragin, acting assistant secretary of Defense for Reserve Affairs. "Both the study itself and its follow-on recommendations will significantly enhance Secretary Cohen's efforts to build a fully integrated Total Force that is able to respond to a wide range of missions well into the next century."

The reserve components consist of the Marine Corps Reserve, Naval Reserve, Coast Guard Reserve, Army Reserve, Army National Guard, Air Force Reserve Command, and Air National Guard. AFRC and ANG constitute the Air Force's air reserve components.

Within the Air Force, the study examined whether it would be useful to establish a certain number of associate program squadrons comprised of reservists to fill shortages in O/A-10, F-16, and F-15C squadrons so that those units would be fully staffed in wartime. Under the associate program structure, reservists and their active-duty counterparts serve together maintaining and flying the same aircraft.

The study recommends evaluating the feasibility of transferring one squadron of B-52 aircraft and one squadron of B-1B aircraft from the active force to the air reserve components as a means of cutting costs and reducing the current active-duty pilot shortage. This follow-on study would examine, at a minimum, the operational impacts, and basing and conversion costs associated with the transfer of the aircraft and their missions.

The Reserve currently has a B-52 squadron at Barksdale Air Force Base, La., and the Guard has a B-1B wing at Robins AFB, Ga.


The study also considered whether converting one active-duty fighter wing equivalent to the reserve components would enhance the U.S. ability to respond effectively during a major theater war. Since such a conversion might worsen the active force's operational tempo and would incur substantial near-term costs, the study recommended a study to examine the costs and benefits of this conversion in more detail.

In examining the role of the Reserve components in the future, the RCE-05 study focused on three areas: homeland defense, smaller-scale contingencies and major theater wars. In each area, the study reviewed several different initiatives, and for each one either recommended a near- or mid-term action, or determined that the particular initiative did not merit implementation in the foreseeable future.

To further explore how the reserve components could contribute to the homeland defense mission and to capitalize on existing skills within the Reserves; the study examined the costs and benefits of developing of a joint virtual information operations organization. The mission of the 400-person unit would be information operations and information assurance.

Another initiative looked at lifting the 180-day limit requirement. Title 10, United States Code, Section 115(d)(6), states that volunteer reservists who have been on active duty for more than 180 days must be counted against the active military end-strength levels, which are set by law. The military services must sometimes disrupt mission performance to avoid violating the congressional end-strength authorizations. Lifting this restriction would permit greater and more effective use of reservists, particularly in cases where they are providing tempo relief for active-duty people.

The study supports the proposal in the DOD Fiscal Year 2000 Omnibus to modify

this legislation. The modification would allow reservists to serve for 181 days or more as long as the total number of reservists on active duty does not exceed .2 percent of the authorized active-duty end strength.

The study also reviewed commander-in-chief rotational timeline restrictions for contingency operations. U.S. Central Command requires individual reservists to serve at least 120 days and allows reserve units to perform a minimum of 90 days but prefers that units pull 120 to 179-day rotations. U.S. European Command requires individuals to serve in 90-day rotations, while reserve units must put in a minimum of 29 days. The study examined whether shortening the required number of rotation day would facilitate increased reserve participation in smaller-scale contingency operations such as the Stabilization Force in Bosnia.

The study included participants from the active, reserve and National Guard components of the services and representatives from the Office of the Secretary of Defense, the Joint Chiefs of Staff, and the unified commands. (AFRC News Service from a DOD news release)
